# **NEW! ASURA Photo Gallery**

ASURA has a photo gallery online at <a href="http://asura.asu.edu/photos">http://asura.asu.edu/photos</a> with a set of albums that collect and organize the photos taken of ASURA people and events over much of the life of the organization. There are photos going back as far as the 1993 annual meeting, and photos are being added regularly. You

can find a link to it at this address from our home page, http://asura.asu.edu

The photos come from Dave Scheatzle's and Elmer Gooding's digital collections; from photos contributed by them, by Val Peterson and by others for use on our web site or in *Prime Times;* and from prints that are kept in the AS-URA office. Several people helped with identification of events and people. Hal White, Elmer Gooding, Dave Scheatzle, Linda Van Scoy, Joyce Hartman Diaz and Carol Moore were particularly helpful in that regard.

The Photo Gallery can be viewed online by anyone without login – no User ID or password required! You can browse through the albums or, you can search for a particular name or event.

For purposes of making browsing easy, there are parent albums for things like "Volunteers," "Retirees Day" and "Travel." If you click on one of those album names, you'll usually see individual albums, typically arranged by year, with the most recent event first. If you click on one of those child albums, on the right you'll see thumbnails of the photos. You can click on any thumbnail to see a larger version and information about it, and in most cases there is also a high definition version available.

When you are viewing an individual photo, you can move forward or backward through the album using arrows in the upper right. There is an arrow that points upward that takes you back to the page of thumbnails that you were most recently viewing. You can also view the photos in various sequences using a "sort order" pull-down box in the upper right area.

If you'd like to search for a person or for a word such as "Scholarship," enter the name or term in the "Quick search" box on the left under "Menu." Try it with your own name if you've been to one of our events! Be aware that the search engine will return all photos that have the searchedon name in the photo title or description or in the album description. There is also a search option that lets you be more specific about what you're looking for, such as for a person in a particular parent or child album.

The Photo Gallery provides ASURA with an enjoy-

able pictorial history. It also is a valuable resource when photos are needed to enhance a story – our own, or sometimes someone else's. We don't copyright our photos but we do like those who use them to provide attribution, particularly if our photo lists the photographer (called "author" in the gallery).

If you have photos of our volunteers at work or of our events, we would be very glad to receive them. We would, of course, like to have your contributions come with information about who is in the photos, and when, where and by whom the photos were taken.

You can contribute by email to *connie.mcneill* @asu.edu or you can call at 480-945-3565 to arrange another method of contribution. Also, please contact me if you find photos in the album that are incorrectly labeled or that are missing labels. There are several people listed as "unknown"... could one of them be you? Try typing "unknown" (without quotation marks) into the quick search box to see.

# **Video History Project Expands**

As of the end of the 2012-2013 academic year, the ASURA Video History Project has 94 completed interviews and 23 video clips. The production process was greatly improved with the acquisition of a dedicated recording studio in Room 203 next to the ASURA office suite that allows the equipment and furnishings to be set up permanently which saves both time and labor.

Another acquisition is an additional video camera which will provide a more professional product. One camera will be used for a close-up of the person being interviewed while the second camera will be set to show both individuals – the interviewee and the interviewer. It also allows interviews with two people to provide for discussion. Perhaps most important, a second camera provides back-up if, for example, the battery runs down on a camera.

There are now more than 20 short clips (1-3 minutes) ready to view. Go to <a href="http://asura.asu.edu/VideoHistory">http://asura.asu.edu/VideoHistory</a> to access this clips and scroll down to the list of interviews. Those individuals with the words "video clip" following their information have a short clip you can view; just clink on "video clip" and when the video appears, click on the play arrow and enjoy.

The committee added two members this year: Becky Reiss as scheduler and Ann Patterson as an additional interviewer. Continuing crew members worked hard this past year and recorded 14 interviews. # **ASRS Health Liaisons**

The ASURA Bylaws define a number of committees and liaisons but how many of you actually know what these committees and liaisons do? I think it is important and useful that you know more about some of these committees/liaisons to better appreciate the level of effort these volunteers put into the task. For this edition of *Prime* 

Times I have selected the ASRS Health Insurance Liaisons.

As you are fully aware health insurance is one of your more important recurring expenses. It also often turns out to be one of the more apparently complicated aspects of retirement what with changing Federal and State Policies and an annual open enrollment period. To address these and other health issues the ASURA Bylaws define the Health Insurance Liaisons. Historically there have been two liaisons, one for the Arizona State Retirement System (ASRS) health insurance and one for the Arizona Department Of Administration (ADOA) health insurance who work together to help ensure that you have the latest health insurance information. The liaison has three major responsibilities: Open Enrollment, Information Dissemination, and Arizona Legislature.

### **Open Enrollment Responsibilities**

- In early fall, in collaboration with the Seminar Committee and any other health insurance liaisons, the liaison helps prepare a seminar(s) to help you manage open enrollment.
- In late September or early October the liaison monitors
  the ASRS web site looking for the new ASRS Retiree
  Group Insurance Open Enrollment Guide. Once the
  guide becomes available the liaison reads the guide to
  become familiar with current member benefits and restrictions. They further get links to the guide and the
  schedule of the ASRS Open Enrollment Sessions
  posted on our website.
- During the open enrollment period the liaison helps you interpret the materials in open enrollment guide and strongly encourages you to attend one of the ASRS Open Enrollment Sessions held during open enrollment.

### **Information Dissemination**

- During the year the liaison keeps you abreast of ASRS benefit implementation and/or changes through *Prime Times* and the ASURA Web.
- Also during the year the liaison will field your ques-

tions via e-mail or phone calls.

• The ADOA and ASRS health insurance liaisons gather various resources pertaining to the Affordable Care Act (aka Obamacare) and Medicare and share this information with you through *Prime Times* and the ASURA Web. Note: This activity is an aside to the liaison's Bylaws defined responsibilities, which are focused on the specific benefits/restrictions of ASRS and ADOA programs.

### Arizona Legislature

During the legislature session the liaison views "Bill tracker" on the ASRS web page and brings important health insurance issues to the attention of the Board and the ASURA ASRS Legislature Liaisons. The Board may ask the Health and Legislature liaisons to actively work for or against the proposed health legislation which requires time at the Capital.

Over the years these duties have been admirably handled by Dick Murra and more recently by Doug Johnson, Rose Minetti and Art Ashton. We currently have three ADOA health liaisons (Art Ashton, Phyllis Primas, and Patricia Moore) but no ASRS liaison. And while the three ADOA liaisons can do something for ASRS, it is important to have an ASRS liaison who has a stake in the game, i.e., is on an ASRS health insurance plan. ### The Gazelles African Adventure

Thirteen excited ASURA travelers set off from Sky Harbor on March 23<sup>rd</sup> to fly to Africa. We picked up a 13<sup>th</sup> Gazelle at Dulles International, a soon-to-retire Wolverine professor from the University of Michigan.



It was a long flight across the Atlantic to Johannesburg, South Africa, with only a brief stopover in Daka, Senegal, to break up the flight. Seventeen hours on board is a long time but, how else to do it? We were setting off on an adventure of a lifetime: to

visit four southern Africa countries.

We arrived in Johannesburg in the evening and went

right to our hotel for the night. The next morning, we were back at the Johannesburg airport for a brief two-hour flight to Victoria Falls, Zimbabwe. From there we drove by minibus into Botswana to Chobe National Park where we began our animal game drive viewing adventures that spanned four very isolated camps in preserves and national parks in three countries: Botswana, Zambia and Zimbabwe.

Each of the four camps consisted of about eight tented cabins and a main building that was the dining area and lounge room. The cabins had hard floors, a bathroom and shower, and electricity. It was very common to hear elephants and hippos during the night as they passed by, grunting and woofing and eating.

After breakfast we would board lorries at about 7 a.m. for our early morning game drive which would last 3-4 hours with a midmorning break for tea or coffee. Our guides were excellent in their knowledge of animals, their likely whereabouts and their behavior. Every day was an incredible school day for the Gazelles.

We saw literally thousands of animals over our threeweek adventures, many quite up close. The lorries we rode in did not seem to bother the animals but we were cau-

tioned not to speak out loud – only in whispers – nor to stand up nor extend our hands or arms out from the lorry. When our driver/guide spotted animals of interest they would drive slowly closer and then stop so we could observe and take a picture or 50.

We were very isolated and generally moved from one camp to the next by riding in our lorries for an hour or so to a dirt landing strip. Two small planes would arrive and we would fly to the next camp, arriving about mid-afternoon in time for a game ride for a few hours. At Lufupa Camp in Zambia we were right on the river where hippos were common; at the camp in Hwange National Park in Zimbabwe we could look up from our breakfast omelet and watch an ostrich or kudu strut across the plain in front of us.

Perhaps the most exciting and intriguing experience was watching a pride of lions devour a giraffe they had

brought down the night before. The pride were stretched out resting under some nearby bushes where they would remain for the next three days, eating on, and protecting, their kill from other predators.



Les Hightower expressed his opinion of the trip: "It is said that the joy is in the journey and for 14 people the joy

was the journey AND the people who shared it. The thread that bound us was everyone's connection to ASU. What united us was how quickly the group jelled and looked out for one another on this fabulous adventure called Ultimate Africa.

"This was my second trip abroad with the ASU Retirees Travel Group. Each is more amazing than the last. I'm looking forward to the next one."

## The Loss of a Great Leader

ASURA lost one of its past presidents on April 23, 2013. Madelyn Wright was the seventh ASURA president (1997-98), a member of the first elected ASURA board (1992-94) and the first elected ASURA treasurer (1992-1994).

Aside from her board duties, she served on several committees including Adopt-A-Family. As president of the ASURA, in an effort to strengthen the already strong legislative relations efforts, Madelyn worked closely with Hal White, who headed the legislative relations program.

Madelyn felt strongly that it was important to foster a bond of friendship among the ASURA members and to this end she promoted and attended many ASURA events (trip to Scotland, numerous annual meetings and holiday potluck parties). She oversaw the establishment of a fund which could be used to support the ASURA Scholarship, an endowment that has grown to more than \$40,000.

During her 30 years of employment at ASU, Madelyn held many positions, including assistant registrar and direc-

tor of the Academic Scheduling Office. Her knowledge of all the classrooms and academic space was terrific. She knew the campus extremely well and scheduled classrooms to accommodate the rapid enrollment growth at ASU during her years of service. She loved her work and the people with whom she worked and showed that love through her captivating smile.
