### President's Message

In my last letter I mentioned two issues I wanted to address: increased membership and event attendance, and increased information on health and health insurance. Here's an update:

The issue of membership and event attendance morphed into something more inclusive. During the summer the ASURA Board and I began working on the possibility of surveying our members to help the Board improve our member recruitment and retention efforts. By the end of the summer I had articulated the following four strategic goals which I presented to the Board in September:

Goal 1 - Increase Membership

Goal 3 - Review Community Outreach Portfolio

Goal 4 - Ensure Long-Term Health of the Association

These are not new goals but they helped me understand better what the Board considers as it makes decisions about the Association.

I further proposed that a survey of our members and potential members would be useful for addressing the first three strategic goals. I felt the fourth goal was best addressed by the Board and its committees. The Board unanimously approved the concept and four survey question groups were created. If we keep on schedule you should see the survey in early January.

As for health issues, good progress has also been made. Art Ashton, Pat Moore and Phyllis Primas, our Health Insurance Liaisons, have worked closely with Jan Thompson and her seminar committee to develop a very ambitious seminar in early October. The liaisons have also been working with Connie McNeill, our webmaster, to improve the information on the ASURA web Health Insurance page. I encourage you to visit the page; I think you'll be impressed.

I hope you all have productive autumns and find our menu of fall events as appealing as you did the Meet & Greet!

### **Your Books** = Needed Scholarship

Now that you're settled (or still getting settled) in your retirement from ASU, you – like many of us – may find that you have more books in your home or office than you know what to do with. ASURA can help solve that problem and, in the process, help a deserving student complete his or her studies.

ASURA collects donated books and sells them online through an established vendor, who splits the sales proceeds with ASURA. Proceeds are put toward ASURA's annual scholarship, which currently is \$10,000. The student who is selected is either a returning student (one who has been away from higher education studies for a period of time) or to a community college student, based on financial and other criteria.

Tomas Espinosa was selected by the ASURA to receive this scholarship for the 2013-14 academic year. Like his predecessors, Tomas must: be a full-time student, complete a minimum of 24 semester hours during the academic year, attain a minimum 2.50 GPA, and make a short presentation at the ASURA annual meeting in April, 2014.

Donation books can be delivered to the ASURA office in the Community Services Building, Room 201B, 200 East Curry Road in Tempe. You will receive a gift tax receipt from the ASU Foundation, which administers ASURA's accounts.

It will come in handy if you have a problem." The offering agencies can be very helpful if you are having problems resolving an insurance issue with one of their carriers.

To find out, contact both ASRS and ADOA (you may have dental insurance from one and health insurance from another, for example) and ask them if their records show you as enrolled in their health programs, and if so, in which.

### **Revisions to ASURA Bylaws**

In September 2011, then ASURA president Bill Moor appointed an *ad hoc* committee to consider improvements to and recommendations from ASURA members, for the ASURA Bylaws. Members were polled through email or letter between December 18, 2012 and January 31, 2013, and approved the proposed amendments. There were two material changes:

### **ARTICLE III.A. Membership Eligibility**

Two new categories of individuals are now eligible for membership:

- Retired persons who were former employees of ASU but may have worked elsewhere after leaving ASU
- 2. Retirees from other universities

# ARTICLE III.B. "Membership Fee" or "Donation" changed to "Dues"

The current membership form refers to the annual fee of \$30 as a "membership fee" rather than "dues." The form also allows for "optional donations" beyond the membership fee. There has been discussion of whether ASURA may refer to the \$30 payment as "dues." After conferring with the ASU Foundation, which manages ASURA's accounts, the Bylaw uses "dues" to refer to the annual membership fee.

# Nominations Sought for ASURA Board of Directors

Nominations are currently being sought for those retirees interested in serving on the ASURA Board of Directors.

The nomination process started October 1 and ends January 1, 2014. Final selection of nominees will occur no later than January 31, 2014. Duties of an ASURA board member are presented in the ASURA Bylaws and are avail-

able on the ASURA website.

Anyone interested in serving on the board should submit a statement of interest to Nominating Committee Chair Bill Moor no later than December 31, 2013. You may nominate yourself or another ASURA member as a potential board member. To be sure that your nominee's name gets on the ballot, submit a petition of nomination bearing the signatures of at least ten (10) current ASURA members. All other nominees will be evaluated by the nominating committee.


