- Are your bookshelves too full?
- Are you downsizing your office or your home and don't have space for all of your books?

Donate your used books to us, and we will work with our partner, Friends of the Phoenix Public Library, to sell them. We'll use proceeds of the sale to support our programs. Half of the proceeds will be used for our ASURA scholarship that goes to an ASU student, and half will be used for our Video History project. The ASU Foundation, a separate nonprofit organization that exists to support ASU, will provide you with a gift receipt for tax purposes.

If you have books to donate, first box them up. If you need boxes, you can pick some up from our office. Be sure to call before coming to make sure we have boxes on hand and a volunteer in the office.

- <u>When boxing your books</u>, please do not overfill the boxes and leave sufficient room to cover or close each box.
- <u>When the books are in boxes:</u> For books that are on an ASU campus, ask Facilities Management to pick them up and deliver them to us. To accomplish this, your department assistant can complete and submit a <u>FACMAN service request</u> on an on-line form. Facilities will schedule a pickup date with the office assistant. Advise the office assistant to provide your name and department to the FACMAN representative who picks up the books, **or** bring your boxes of books to <u>our office</u>. Parking is readily available by the building. We have a dolly you can use. There are 3 ramps into the building, and an elevator to the 2nd floor.

Government Liaison's Report - Spring 2021

The 55th Legislature First Session started as scheduled in January 2021 and there is a lot of business to do! The last legislative session's work came to a halt in the middle of March 2020 when the Governor released its first COVID-19 executive order. An on-again-off-again legislative schedule last spring had the House and Senate working at different times, resulting in a bare bones FY20-21 budget and hundreds of bills left waiting. But our lawmakers have hit the ground running in 2021, with bills already introduced and moving through the appropriate standing committees.

Here are some of the bills we are watching this spring:

- HB2008 ASRS: employer; member; contributions
- HB2028 Treasurer; investment of trust funds
- HB2059 Retirement systems; benefit computation; return-to-work
- HB2138 ABOR; optional retirement programs
- HB2139 ASRS; self-insurance program
- SB1052 ASRS; required beginning date; distributions
- SB1053 ASRS; non-participatory employer liability
- SB1054 ASRS; self-insurance program









Governor Ducey gave his State of the State on January 11, 2021. It was short, under half an hour, and the first half of his address was spent defending his Covid-19 response decisions. The Governor stated that his first priorities are getting the economy up and running, cohesive government and providing a comprehensive coronavirus response and the related addiction, suicide and mental health issues. Other priorities are:

- Opening schools and getting kids caught up. *Governor Ducey did make some confusing statements about not funding "empty seats". Those statements were later clarified, the Governor is not denying funding to schools who are teaching remotely.
- Tax reform and lower taxes
- Eliminating unnecessary state buildings
- Broadband expansion, greater access to telemedicine
- Better roads and bridges
- World leader in water innovation
- Better equipment and training for law enforcement
- Criminal justice reform
- Guarding against wildfires

The Arizona Board of Regents' stated focus this legislative session is on their state budget request. Their new funding model is *The New Economy Initiative*, which is designed to enhance Arizona's competitiveness with strategic investments in our three public universities. Under this model ASU will design and launch the largest engineering education and research center in the United States. Northern Arizona University will provide talent in the high demand mental and behavioral health care fields. And the University of Arizona will enhance medical professional and research, increase capacity for careers in national security, space technology and planetary defense and establish Arizona's only School of Mining to develop Arizona as a world-class leader in mining for the 21st century. ABOR believes this targeted approach toward workforce development in high-value industries will yield a positive return on state investment.

In addition to the New Economy Initiative budget request, ABOR is asking for monies for Distributed

Learning Centers, which will enhance the viability and scale of university learning centers throughout the state, with special focus on rural counties. They are also requesting enhanced funding for need-based financial aid for Arizona high school graduates, increasing homegrown talent through a transparent state-sponsored program. Lastly, ABOR is asking for an FY21 supplemental budget allocation to restore funds from past years and to cover pandemic shortfalls.

Lastly, in light of this past year's turbulent election and civil unrest, Arizona Congress is considering a probe of GOP lawmakers at the US Capitol during the riot, subpoenas to examine election equipment and Arizona voter records, the Governor's tax reduction proposal right after the voters approved Prop 208 and security at the Arizona Capitol as armed citizens continue to protest the handling and results of the November 2020 election.

We are pleased to have a growing team of "ASU Retiree Association Legislative Watchdogs" monitoring the bills as they move through the legislative process, attending retiree related meetings and conferences and working with state and local representatives. My thanks to Tara Roesler, Pat Schneider, William Stasi, Larry Carlson, Dick Jacob, Suzanne Bias, David Gay and Martha Cocchiarella and all of our members who bring issues affecting retirees to our attention. Governor's Advisory Council on Aging - Spring 2021 Report

The Governor's Advisory Council on Aging (GACA) gathers and assesses information about seniors' needs and aging trends by monitoring and raising awareness about programs and policies that affect older adults. GACA helps to support the ongoing work of the Community & Legislative Partners in Aging (CLPA) meetings, hosted by Senator Heather Carter, Senator Lela Alston, Rep. Regina Cobb and Rep. Jennifer Jermaine and AARP. The Governor's Office of Youth, Faith and Family (GOYFF) values this long-standing relationship and looks forward to



supporting this partnership and engaging with stakeholders to enhance the quality of life for older Arizonans.

one meeting in the Fall of 2020. CLPA also promoted the World Elder Abuse Awareness virtual conference (please see Pat Schneider's article in this Prime Times) and shared information on an End Well virtual event in December.

Alzheimer's During the Coronavirus Pandemic was held on November 17, 2020. This meeting's discussion was centered around Alzheimer's — a disease that affects everyone in some way. The guest presenters were James Fitzpatrick, Director of Public Policy for the Alzheimer's Association-Desert SW Chapter and Dr. Eric Reiman, Director of the <u>AZ Alzheimer's Consortium</u>.

James Fitzpatrick started the discussion with an update from the Arizona Alzheimer's Association. Arizona has had the fastest growth rate of the coronavirus in the United States and Covid-19 is the 4th leading cause of death in our state. This virus has uniquely and negatively affected the Alzheimer's community and those with dementia. Communication and cognitive skills decline swiftly with family visitation restricted and caregivers are overtaxed. Many caregivers suffer from stress and related diseases and have to quit working altogether. Support group participation has declined. Access to community services is essential, but severely impacted by Covid-19.

Dr. Reiman discussed Alzheimer's therapies and prevention. There is a consensus within the AZ Alzheimer's Consortium, a statewide collaboration in Alzheimer's Disease research, that there will be a prevention therapy within the next five years. Consortium partners at ASU, Banner Alzheimer's Institute and Sun Health Research Institute, Barrow Neurological Institute, Mayo Clinic, Tgen and University of Arizona, are working together to develop best practices for research and care, with the goal of a prevention therapy. The state and federal government are funding 50-60 new studies a year. Next year's prevention trial, using subjects with no symptoms but brain indicators such as amyloid plaques, will employ an amyloid antibody. If successful there could be a gene therapy in 2025.

Presently the FDA is in the process of approving an affordable blood test which identify amyloid plaques. As of right now 60% of patients with Alzheimer's are never tested or diagnosed with the disease.

"World Elder Abuse Awareness Day" Virtual Conference — November 9-10, 2020

The *World Elder Abuse Awareness Day Virtual Conference* was a live, virtual event hosted by the Arizona Department of Economic Security. The target audience for the conference was individuals and communities that serve and advocate for the elderly and vulnerable communities, such as the developmentally disabled. The conference provided people from government agencies, non-profit and for-profit organizations and service providers an opportunity to network and connect.

The event was held over two days, November 9-10, 2020, and consisted of keynote speakers and over 25 different breakout sessions. The tracks were broken up into seven (7) different categories covering advocacy in long-term care facilities, emerging issues with older adults, family caregivers, integration and risk reduction of vulnerable populations, interpersonal violence, legal and safety. This article will focus on highlights from two (2) of the sessions.

Preventing Caregivers Compassion Fatigue

Dr. Dorothy J. Dunn, an Associate Professor of Compassion Fatigue at Northern Arizona University, School of Nursing, presented how research is being done on compassion fatigue that manifests itself within both the formal and informal caregiver. She started by defining what compassion fatigue is ... a term that describes the physical, emotional and psychological impact of helping others often experienced through stress or trauma. Not to be confused with burnout, compassion fatigue encompasses a more specific experience, which may be brought on by a stressful environment, lack of resources, of excessive hours spent in compassionate care.

She outlined the main phases associated with Compassion Fatigue:

- Enthusiasm Ready to take on the world; desire to help wherever needed doing whatever needs to be done.
- Irritability Things are not going quite as was expected; overwhelmed; concentration off; starting to distance yourself from the person(s) you're taking care of.
- Withdrawal Start to neglect things, whether this be regular tasks to personal hygiene; complain a lot; tired all the time even if you are getting appropriate rest.
- Zombie Irritation turns to anger; don't want to be with any people; no time for fun; checked out on life; suffer in silence.
- Recovery Reach out for help; recognize what your triggers are and what to do when they hit; self-examination of yourself; develop a plan to re-enter "normal" life.

Dr. Dunn stressed that it's important for caregivers, in any capacity, to take time to care for themselves. She emphasized the importance of identifying the triggers that indicate you are getting fatigued, like constant sighing, so you know when you are headed to fatigue. It's important to find your "respite" area, the place you can go to just to relax, like a favorite chair.

She strongly urged that you seek help. It's **NOT** a sign of weakness and better to do before reaching the withdrawal or zombie stage. Let other people help with tasks. Sure, they may fold the towels a bit differently than you do, but at least they are getting folded! Also, don't forget about your nutrition. Finally, if you don't take care of yourself, you won't be at your best to be present for the person you are taking care of.

Living Alone with Dementia; Addressing Challenges to Help Reduce Risks for Abuse

Dr. David W. Coon is a professor and researcher in the Center for Innovation in Healthy & Resilient Aging at Arizona State University. Dr. Coon presents the need of the growing number of people living alone with dementia and provides steps to address challenges experienced by this population.

Dr. Coon indicated that there are multiple steps that should be taken to help reduce risks:

- Identify those who are living alone with symptoms of dementia
- Build trust
- Involve family and friends
- Support safety and autonomy
- Coordinate with paid providers and formal support services
- Assist with transition to a new setting

Plan for the future

- 1) Building support for the person living alone was a key component to the presentation. Dr. Coon presented suggestions that one should take in addressing the needs of the individual.
- 2) Perform functional assessments to help identify the specific support the individual need. One of these includes financial stability. It is also important to keep culture and diversity at the forefront to help ensure dignity and respect based on the individual's background when performing the assessment.
- 3) Assess the living situation:
 - Can they prepare meals or grocery shop?
 - Can they perform daily hygiene tasks?
 - Are they wandering?
 - Can they take care of financial obligations?
- 3) Build a care team in consultation with the individual. Keep in mind that teams provide support, encouragement and help implement the individual's wishes and care plans.
- 4) Identify family and friends who can provide support, assist with care, and schedule and accompany the individual to doctor appointments. Involve more than just one person in the care responsibilities.
- 5) Make use of agencies that provide services.
- 6) Plan for safety and autonomy:
 - Nutrition, hygiene, and medication management --- decide with the individual what they can manage on their own and what they would like help with.
 - Financial safety Direct deposit of social security and any other income.
 - Transportation safety Identify drivers and/or transportation services to assist the individual to get to appointments as needed.
 - Personal and home safety Identify what help may be needed to do household chores or just to check on the individual's status regularly.

Dr. Coon recommended that each of us should start thinking about these things and preparing for our own future care!
